The financial statement is prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The supplementary budget information contained in the statement of revenues and expenses – actual vs. budget – fiscal year 2022-2023 – cash basis is presented for purposes of additional analysis and is not a required part of the basic financial statements. Such information is the responsibility of management. The supplementary budget information was subject to our compilation engagement. We have not audited or reviewed the supplementary budget information and do not express an opinion, a conclusion, nor provide any assurance on such information.

Management has elected to omit substantially all the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statement, they might influence the user's conclusions about the Company's assets, liabilities, fund balance, revenues and expenses. Accordingly, the financial statement is not designed for those who are not informed about such matters.

Banner Program Guidelines





Guidelines and Pricing

The Salinas City Center Banner Program provides an opportunity for nonprofits that benefit the general community to promote an event or exhibit that impacts Salinas City Center. With employees, visitors, and locals frequenting the district, this is a high-visibility opportunity for organizations to showcase their work.

How it works

- 1. Client Organization reviews Banner Guidelines.
- 2. Client Organization submits an application (with artwork proof).
- 3. Applications are reviewed by SCCIA staff.
- Client Organizations are notified if their banners are approved or rejected.
- If approved, Client Organizations will have banners printed by THEIR preferred vendor and delivered to either Monterey Signs or the SCCIA office for storage.
- SCCIA staff will coordinate installation and removal of banners.

Program guidelines

- Participants must follow Banner
 Style Guide guidelines.
- Banner applications are processed and considered on a 'first-come, first-served' basis and can be sent up to one (1) year in advance.
- All participants must sign a contract for a specific period of time during the year, not to exceed 30 days for Main Street and 90 days for Alisal Street, Monterey Street, and Salinas

- Street. This period of time may be reserved annually as determined by the SCCIA, at which time the application may be renewed.
- Banners can be used to promote events within Monterey County, the City of Salinas, and Salinas City Center. If conflict occurs on timing, priority will be given to events occurring within Salinas City Center,



- City of Salinas, and then Monterey County.
- A participant must be a nonprofit (501(c)3) organization or other eligible not-for-profit organization.
- The event, activity, or exhibition must align with the SCCIA's mission in regard to promotions and beautification efforts.
- The name of the event, activity, or exhibition shall be displayed on the banner and may also include date and organization name. No other messages, statements, names, or paid sponsors' logos are permitted.
- All designs must be co-branded with the SCCIA Logo at a minimum size of 6" x 6".
 - Banners displayed to honor individuals or In Memoriam are exempt from co-branding.
- All participants' artwork and messages will be subject to approval by the SCCIA.
- To participate, the SCCIA must coordinate the installation of banners. Printing may be done by Client's preferred vendor.
- Client Organization agrees that banner installer or SCCIA is not responsible for any loss, damage, stolen, or vandalized banners while displayed on light poles.
- Client Organization agrees to pick up banners within five (5) days after removal. After five (5) days, installer or SCCIA is not responsible for lost,



damaged, stolen, or discarded banners.



Banner Specifications

- Banners shall be two-sided with information contained on both sides.
- Banners shall be made from industrial grade matte finish vinyl, marine acrylic canvas or other durable cloth, nylon, or substance of similar effect. Fabric must be durable, fade and weather resistant, repel water, be impervious to rotting, guaranteed non- shrink, allow printing with no bleeding.
- Banners shall include:
 - Grommets on the top and bottom corners of the pole side of the banners;
 - A reinforced hem to include at least two fabric layers along all sides and around the grommets at both corners

- Banners shall be zip-tied to the horizontal bracket poles to ensure safety.
- Banners shall include a reinforced loop on the top and bottom borders of the Banner for slide-mounting onto horizontal bracket poles (pole pockets).
- Banner content, text font size and style should be sufficient for maximum multi-modal transportation visibility.
- Main Street banners should be self-contained on 1 banner and not require 2 banners side-by-side to complete the design. We cannot guarantee 2 banners per post due to existing traffic signage.

- Alisal Street banners will run from Capitol Street to Monterey Street.
- Monterey Street banners will run from San Luis Street to Market Street.

- Main Street banners will run from the Steinbeck center through the 100, 200 and 300 block. Banners can be ordered for full coverage (every pole) or half coverage (every other pole).
- Other locations will be assessed on a case-by-case basis.




